

Membership Donations – The foundation is grateful for the ongoing support of our membership. Thank you for your generous donations of \$1788.






AAOHN Foundation 2022 Financial Report



The Foundation saw a decrease in giving during 2022. We experienced a 54.64% decrease in contributions from 2021. Overall, the Foundation collected \$28,750 in contributions for 2022 due to inability to host usual fundraising events through the virtual conference platform.



In 2022, 64% of all
Foundation expenses were considered charitable, meaning those expenses paid to AAOHN members as scholarships and grants. The other 36% were considered non-charitable expenses such as consulting, storage fees, bank fees, tax filings, postage and funds not recovered



The AAOHN Foundation received \$28,750 in gifts, grants, and contributions from donors in 2022. Due to pivoting to a virtual conference plan, the Foundation was unable to host the usual fundraising events. The Foundation did provide an educational program at no cost to attendees in recognition of their work through the pandemic. The Foundation ended 2022 with \$28,750 in revenue, \$44,354 in expenses for a net gain of \$15,604. In 2022, the Foundation had a spending ratio of 64%, meaning that 64% of all expenses were awards for educational scholarships and scientific research, while 36% were spent on administrative expenses, 6% on the annual conference and 0% towards contribution expenses.
